COGGINS: A current, negative coggins test is required for ALL horses.
RIDE TIMES: Available on CFD web site the **Thursday** prior to the show.
LATE ENTRIES: Late dressage entries will be taken if space allows. There is a \$20 late fee. A late entry is an entry mailed or received via email or fax after the closing date. If you fax or email an entry, payment must be mailed (postmarked) by the closing date.
